Roy writes that his father and mother married on December 20, 1944, but that his father returned to the U.S. before his birth and he was attempting to, now, learn more of him. Roy wrote "He (Erwin Grant Rose) was based at Rackheath near Norwich in 1944-45. mother thinks he was a gunner on a B-17. He came from Kentucky. She cannot remember his Dewire No. (ASN?)".

If his father crewed on a B-17 he would not have been at Rackheath. Roy wrote his father would be 79 years old and quite possibly has

In some records I have, I found a Sgt. Burt E. Rose who was on John Thompsons crew, one of the original 467th crews arriving at Rackheath in early 1944. Don't believe this is the same man.

NOT-FOR-PROFIT CORPORATION PROPOSAL

I asked William P. (Bill) McGovern of Oak Creek, WI, as a lawyer, to give me his opinion as to incorporating the 467th Bombardment Group as a non-profit organization. Bill wrote he believed it should be done and gave the following reasons.

(1) Tax exempt status could be sought so that those donating to the group would receive

exemptions;

(2) The corporation would have the effect of insulating officers and directors from personal liability in claims or suits against the

(3) Reduced postal rates could be used;(4) The corporate setup would be permanent in nature and would provide a more orderly procedure for the election of officers and directors and the handling of corporate assets and charities.

Bill wrote further "I believe that Wisconsin is as good a state as any in which to incorporate the group. Its laws provide that officers and directors may reside out of the State of Wisconsin and that meetings of members and directors may be held at any place which may be determined by the officers. The corporation will have to maintain a registered agent in the State have to maintain a registered agent in the State of Wisconsin whose only duty would be to accept service of process in the event the corporation is sued. I could serve in that capacity for the present and the corporation trust company could at any time be retained to serve in such capacity. I would provide for the full incorporation without any cost to the group.

I recently organized the Vietnam Veterans in Wisconsin and am enclosing copies of the incorporation papers and also the Consitution and By-Laws. I believe that these By-Laws, with certain changes, would fit ideally into our type of situation.

I would be pleased to form this corporation at any time that you might so desire. Please contact me."

A copy of Bill's letter and attachments has been discussed with and sent to Dave Swearingen. In all probability this will be an agenda item at our reunion business meeting. If you have advice or input to this item, please write them to Dave as soon as practical.

A Mission Report From Charles C. "Chuck" Russell

Mission to Lubeck - June 18, 1944

The group was scheduled to be part of a big strategic offensive operation into Northern Germany, the first since D-Day. These large raids meant a long mission because the assembly of the squadrons, groups, wings and divisions into the bomber stream reguired a lot of careful and physically demanding flying. Joining the

Squadron at the assembly point was no problem for me for I had been doing it so long it became very. easy. Then it was just a matter of staying in formation while the circle of assembled groups widened to form into wings; wings into divisions; and the three divisions into a bomber stream. It was beautiful to observe. Someone had done a superb job of figuring out the timing so that everything came together with such precision. We headed out over the North Sea flying close enough to Helgoland to wake them up so they could throw up a few rounds of flak to let us know they were still there.

At briefing that morning I had been issued a pair of sunglasses and told to try them out. They were a different color from the usual green sunglasses we were used to. I think they were an amber tinted glass. I was supposed to report back how effective they were and how I liked them. I did not wear any sunglasses on missions for the bright sun and glare did not bother me and the glasses were just a nuisance. Sunglasses, to me, were just to be worn in to town when trying to impersonate a flyer. On this day I did wear the glasses they issued to me.

We were near the town of Lubeck when started to receive very accurate flak. The bursts were close enough you could hear them. received one burst very near that shattered the windshield on my side of the aircraft. The ship we were flying did not have bullet proof glass in the windshield and side windows as some did. The bullet proof glass was a confort in the area where enemy action could be expected but a real pain when returning to base. At lower altitude the glass frosted over and it took a lot of scraping to keep it clear, then when the glass warmed up a bit the moisture condensation was so heavy it took a lot of wiping to have a peep hole and lots of time that's all you had. The chamois skin inside of the face masks the Red Cross knitted for us was a big help in keeping the glass clear after the condensation started.

Cold plexiglass shatters into a million little razor blades when struck with something like flak. My glasses were instantly coated with fine ground plexiglass. My jacket was cut by the flying pieces. My forehead between the helmet and the sunglasses was cut in several places. I yelled for the co-pilot to take over for I could not see. I removed the sunglasses, which saved my eyes, and they were pitted by the flying plexiglass. The radio operator brushed me off and found some rags to push into the hole to keep out part of the cold slipstream. That was the only damage we received and we flew the rest of the mission without incident.

Back at the debriefing, they said I bled enough to get a purple heart but I was sure thankful that I had worn the sunglasses for they saved my eyes that day.
